Agenda Item 7. Action Items

A. Adult Foster Care Facilities Text Amendments - Public Hearing.

The Planning Commission has determined on its own initiative to amend the Crockery Township Zoning Ordinance, related to Adult foster Care Homes, including Section 3.03 General Provisions, Section 2.02 Definitions, Sections 5.02 and 5.06 Ag-1 Agricultural and Open Space District, Sections 6.02 and 6.06 Ag-2 Rural/Agricultural Preservation District, Sections 7.02 and 7.06 R-1 Low Density Single-Family Residential District, Sections 8.02 and 8.07 R-2 Medium Density Residential District, Section 9.08 C-1 Commercial District, and Section 19.14 Special Land Uses.

Documents provided to the Commission for this hearing include Draft No. 3, an Ordinance to Amend the Zoning Ordinance of the Township of Crockery, Adult Foster Care Homes, dated January 6, 2015.

Mr. Toland provided a brief lead-in to this discussion, indicating the text amendments were largely developed to better organize and clarify language regarding adult foster care facilities within the Township.

Vice-Chair Ryan Arends opened the public hearing.

Mr. Brown helped to guide the review of the proposed ordinance amendments on a section by section basis. The discussion included matters of State law and regulations affecting adult foster care facilities and the proposed amendments to the Township's Zoning Ordinance affecting adult foster care facilities, including how each applicable zoning district might be amended.

As a result of the discussion the Commission recommended a number of language changes and additions to Draft No. 3, which were noted in the text of the document by Mr. Brown.

Public comment was requested by Vice-Chair Ryan Arends. None was offered at this time.

After all discussion was complete and all interested parties heard, Commissioner Jon Overway made **a motion** to recommend to the Township Board that Draft No. 3, an Ordinance to Amend the Zoning Ordinance of the Township of Crockery, Adult Foster Care Homes, dated January 6, 2015, with revisions, be approved. A 2nd was offered by Commissioner Roy Holmes. The motion was unanimously approved by the Commission.

Mr. Brown will further prepare Draft No. 3 for the Board's review.
