### A. <u>Public Hearing – Special Land Use – Silver Vista LLC Self-Service Storage Units.</u>

Documents provided to the Commission for this public hearing include; (1) a Planning and Zoning Review authored by Z/A Toland, dated August 16, 2016, discussing the application, (2) a memo authored by Jon T. Brecheisen, present parcel owner of 70-04-23-100-016, dated July 10, 2016, discussing the project and supporting the applicants request, (3) a Crockery Township Zoning Application, requesting approval for self-storage units, signed by Steve Krommendyk, dated June 8, 2016, (4) a memo by Kevin S. Kieft, P. E., of Prein & Newhof, dated August 2, 2016, discussing this project, (5) an e-mail communication authored by Rob VanderVennen, dated August 8, 2016, discussing the application, and (6) a topographic boundary survey of parcel 70-04-23-100-016.

This request is for a Special Land Use permit for self-service storage facilities on a currently vacant parcel, 70-04-23-100-16, located on Cleveland Street, which is presently zoned C-1 Commercial.

Mr. Dale VanderVennen, Mr. Rob VanderVennen, and Mr. Steve Krommendyke were present at this session.

Chairman Bill Sanders opened the public hearing.

Mr. Rob VanderVennen advised the Commission they reviewed the present Township Ordinance (Section 55. Self-Service Storage Facility) regarding storage units and found them be somewhat restrictive. Mr. VanderVennen also noted that several of the present storage operations within the Township do not comply with the present standards.

The Commission, in response, indicated the present ordinance was recently put into place, but would take into consideration the applicants comments.

No site plan was provided during this session by the applicants.

There were no public comments offered during this hearing, apart from the applicants concerns.

Commissioner Rich Suchecki made **a motion** to table this public hearing for further information until Tuesday, October 18, 2016, at 7:30 P.M., at the Township Hall. A 2<sup>nd</sup> was offered by Commissioner Ryan Arends. The motion was unanimously approved by the Commission.

B. Resolution of Intent to Hold a Public Hearing - Special Land Use - Crockery Store N Lock LLC.

Hughes, Job #R120201, dated July 13, 2016, and (3) Construction footprints and elevations by Pioneer Construction and Tailored Building Systems, 550 Kirtland Street, S.W., Grand Rapids, Michigan, 49507, by T. Beltman, Job #16XXX, dated July 12, 2016.

The Commission has received a request from Crockery Store N Lock LLC for a Special Land Use permit to construct a 4,000 square foot addition to an existing self-service storage facility building at 11352 Cleveland Street on parcel #70-04-22-200-018.

**A motion** was made by Commissioner Ryan Arends to hold a public hearing in this matter on Tuesday, September 20, 2016, at 7:30 P.M., at the Township Hall. A 2<sup>nd</sup> was offered by Commissioner Mike Munch. The motion was unanimously approved by the Commission.
