#### **Agenda Item 7.** Action Items

A. Resolution to Hold a Public Hearing – VanderVennen Storage Unit Condos.

Mr. Dale VanderVennen, Mr. Rob VanderVennen, and Mr. Steve Krommendyke were present at this session.

Mr. Rob VanderVennen advised the Commission they had reconsidered the condominium status of their proposed storage units and wished to pursue standard rental storage units instead, as a Special Land Use under Township regulations.

The resolution was amended to reflect a request for a Special Land Use permit for self-service storage facilities on a currently vacant parcel, 70-04-23-100-16, located on Cleveland Street, which is presently zoned C-1 Commercial.

Commissioner Ryan Arends made **a motion** to hold a public hearing in this matter on Tuesday, August 16, 2016, at 7:30 P.M., at the Township Hall. A 2<sup>nd</sup> was offered by Commissioner Mike Munch. The motion was unanimously approved by the Commission.

#### Agenda Item 8. Presentations.

Mr. Toland provided the Commission with a copy of a written request from Mr. Abe Anderson, R & A Investments, 12200 Cleveland Street, Nunica, Michigan, 49448, dated July 14, 2016, requesting a site plan extension. The request is based on the potential development of a neighboring property that may necessitate a change in their (R & A Investments) property's parking lot layout.

After a brief discussion, Commissioner Dave Meekhof made **a motion** to allow a final site plan extension of one (1) year for R & A Investments, 12200 Cleveland Street, Nunica, Michigan, through July of 2017. A 2<sup>nd</sup> was offered by Commissioner Ryan Arends. The motion was unanimously approved by the Commission.

Mr. Toland provided the Commission with a draft copy of Zoning Ordinance Amendments – Conventional Condominiums, Site Condominiums, and Storage Condominiums, authored by Attorney James R. Brown, representing the Township.

The Commission also discussed potential amendments to the Township's Sign Ordinance

Chapter, also suggested by Attorney James R. Brown (in light of the 2015 U. S. Supreme Court

decision in Reed v Town of Gilbert).

suggestions for further consideration in this matter.
